

General sponsorship printing deadline is October 28, 2017**

*A Platinum, Gold or Silver Table sponsor that intends to claim a charitable contribution deduction, rather than a business advertising deduction, will have its contribution deduction reduced by 10% unless by the time of its contribution it waives its right to a submission in the program, but may still be listed as a sponsor in the program without any reduction.

**A Silver Registration sponsor that intends to claim a charitable contribution deduction, rather than a business advertising deduction, will have its contribution deduction reduced by 15% unless by the time of its contribution it waives its right to include any content other than its name on its banners.

***A Bronze Mint sponsor that intends to claim a charitable contribution deduction, rather than a business advertising deduction, will have its contribution deduction reduced by 5% unless by the time of its contribution it waives its right to include any content other than its name on the mint packaging.

Christian Legal Aid of Los Angeles (CLA-LA) is a 501(c)(3) nonprofit corporation providing free legal services to very-low-income residents of Los Angeles County. We hope to raise \$250,000 in 2017 and \$300,000 in 2018.
